I HEREBY PROPOSE: To abate approximately 1,368 square feet of asbestos containing sound board from the band room, the choir room, and two practice rooms, as well as 1,848 sq ft of asbestos containing 9x9 floor tile and mastic from the FACS kitchen area of the Huron High School, located at 801 18<sup>th</sup> St SW in Huron, SD. Sound board will be carefully removed by hand and containerized under negative air pressure. Floor tile will be wetted and removed by hand under negative air pressure and mastic will be treated chemically, unless the owner prefers a different abatement technique (scraping and sealing, for example). The material will be disposed of in an approved landfill. Cost includes air monitoring but specifically excludes all replacement materials. **Pricing good through Summer 2025.**
